REPRESENTATIVE EXPERIENCE

Construction Representative Experience

- Represented concrete contractor in a \$10M+ dispute regarding concrete installed at a major airport runway, that is cracking, and allegedly must be removed and replaced.
- Secured a \$7.9M judgment against the president of a construction company based on a fraud claim, following evidentiary hearing in US District Court for the Eastern District of New York. Also obtained a \$10M arbitration award against this defendant's company for breach of contract and abandonment after his company failed to complete the work they were subcontracted to perform and abandoned the project.
- On a \$100M multi-family construction project, represented a construction company from the drafting of its contract, through securing payment from the project owner and handling all claims and disputes associated with the project.
- Drafted the construction contract for a \$400M high profile manufacturing facility.



- Obtained a complete judgment against a tree clearing company who failed to complete its work, including for attorney fees and punitive damages.
- In Florida, represented the owner of a \$130M multi-family development who terminated the general contractor on the project. Obtained judgment that the general contractor's \$14M+ lien was exaggerated and fraudulent within the meaning of the Florida statute, forcing the contractor to release the entire lien from the project. On behalf of owner, pursuing \$50M breach of contract claim against general contractor and its lower tiers.
- Represented an owner against a general contractor and subcontractor in a two-week jury trial and obtained a \$2.5M jury award.
- Obtained an arbitration award in favor of the general contractor against the building owner on a \$500k final payment dispute, plus interest, defeating claims of non-compliant work.
- Obtained an arbitration award in favor of a general contractor against the roofing subcontractor in excess of \$1.5M.
- Represented a general contractor on a highly visible multi-family project, including a significant payment dispute. Placed a \$4M lien against the project and then participated in multi-party mediation toward resolution over the course of 10 months.
- Served as lead construction counsel to negotiate construction contracts for several high-profile Cleveland projects including the renovation of Park Synagogue and the Cleveland Museum of Natural History.

Real Estate Representative Experience

- Represented real estate investment and asset management company to secure approval for a \$10M development in a suburb of Cleveland, Ohio. Also secured necessary wetlands approvals for the project. Overcame neighbor objections and environmental challenges.
- Represented real estate development group in \$24.4M acquisition of several apartment buildings in Columbus, Ohio and around the US.
