Estate Planning and Special Needs Planning

Jayme began her legal career as a staff attorney at the Center for Disability and Elder Law (formerly the Legal Clinic for the Disabled, Inc.) where she managed the Chicago Department on Aging grant to provide legal services and referrals to at-risk senior citizens in Chicago. With more than 30 years of providing legal services to people with disabilities, Jayme is an invited speaker for special education departments/schools, advocacy groups, service providers for persons with developmental disabilities and trainings for legal services organizations on topics regarding guardianship and planning for persons with disabilities.
