Michael J. Gleason is an AV-rated trial and appellate lawyer with over 20 years of experience handling key areas of business litigation, including consumer class action defense, California's Proposition 65, product liability, fraud, real estate, escrow, and title insurance. He served as Partner-in-Charge of Hahn Loeser's San Diego office for 14 years, is founder of the firm's Proposition 65 defense group, and a member of the San Diego Litigation Team, which is ranked among the Top Tier Practices by Chambers USA.

Mike has litigated jury and bench trials to successful outcomes throughout California. He presented oral argument before the United States Court of Appeals for the Ninth Circuit, as well as the Second, Fourth, and Fifth Appellate Districts of the State of California and has also briefed matters before the California Supreme Court. He represents businesses in a wide range of industries, including escrow, title insurance, real estate, food, manufacturing, retail, oil and gas, entertainment, and consumer credit. Mike has also represented non-profit trade associations including the California Land Title Association and the American Land Title Association.

Mike volunteers on the Board of Directors of San Diego Volunteer Lawyer Program, which provides pro bono legal services to vulnerable San Diego County residents, including the homeless, abused children, domestic violence victims, elder abuse victims, veterans, immigrants and those living with HIV/AIDS. Mike also regularly volunteers at the Feeding America warehouse sorting food with his children and has actively participated in Feeding San Diego's annual "Food from the Bar" competition between law offices for the past seven years. Mike has volunteered as a coach for his son's basketball team for the past three seasons.

and litigation support. Currently defending client in a California lawsuit which alleges the “No Added MSG” label on certain client products is misleading under California and federal law. Also defending client in a separate California lawsuit based on allegations that certain client products require additional labelling based on the content of its ingredients.

- Representing one of the largest title insurance companies in the U.S. in a putative class action pending in Orange County, California. Plaintiffs seek to represent high net worth individuals who invested in multiple commercial properties. These commercial properties are generally large buildings (such as skyscrapers) which are then leased out to tenant businesses with rent going to these individual investors. The properties went into foreclosure during the pandemic when tenants began abandoning the buildings. After the foreclosure, plaintiffs now allege that they never would have entered these commercial real estate investments had the title insurance company disclosed certain information about the investment structures and the parties involved in the investment. Plaintiffs allege multiple counts, including fraud, breach of fiduciary duty, breach of contract, and violation of California’s Unfair Competition Law. Hahn Loeser successfully moved to dismiss all claims. On appeal, however, California’s Fourth Appellate District partially reversed the dismissal and remanded certain claims. Hahn Loeser then successfully opposed class certification. The trial court has now allowed plaintiffs to file a Fifth Amended Complaint with four new plaintiffs—narrowing the claims from twenty commercial properties to six properties—and allowed plaintiffs the opportunity to renew their motion for class certification.
- Ongoing defense of a title insurance company in an action filed in California state court. A commercial developer of several larger condominium and apartment developments in San Jose was sued by the Securities and Exchange Commission for operating a Ponzi scheme involving tens of millions of dollars in which the developer allegedly paid investors of certain development projects with funds from investors from other development projects. The SEC filed a federal action and appointed a receiver to take control of the developer’s projects and business. Client served as the escrow officer for many of the developments. A lender to the developer of approximately \$20M has separately sued client for allegedly aiding and abetting the Ponzi scheme – a dispute also being handled for title insurance client.
