In Southwest Florida business circles, women like Samira Beckwith, Sandy Stilwell or Gail Markham shine as examples of leadership and success. And thankfully for our community, there are scores more. They may differ in style, from high-profile to low key, but their common quality is that they wield the influence to get things done.

So, who are these women power players? We consulted with a number of sources and came up with the following list of 29. Of course, listings of this kind are subjective, and we realize that there are others who may have been missed. We also left out elected officials because of races coming up this summer. But this isn't intended to be a roster of the most popular or recognizable figures; rather it's meant to celebrate Southwest Florida's powerful women.

#### Samira Beckwith

President and CEO, Hope HealthCare Services, Fort Myers

Beckwith has received recognition from a variety of organizations in Southwest Florida and across the country for her work, but perhaps one distinction most aptly describes her strength: She is a National Association of Social Workers Social Work Pioneer. "Regardless of the scale of her work and her accomplishments, Samira Beckwith maintains her focus as a social worker," according to the NASW. The observation undoubtedly stems from her 20-plus years at Hope, which serves more than 2,400 people nearing the end of their lives.

A self-confessed nonprofit junkie, Black has reigned in her position at Lee County's Alliance for the Arts for nearly four years. During that time, the organization has seen significant growth in membership and community arts programming. In acknowledgment of her work, Black boasts various accolades including a *Gulfshore Business* 40-under-40 award.

Growing things is Bridges specialty, whether it's planting a new flower in her garden or cultivating the Center for the Arts of Bonita Springs to its—now—10-acre campus. Bridges was responsible for helping launch the Bonita Springs National Art Festivals, which consistently rank among the nation's best; creating the Art and Academics connected program, which serves thousands of at risk youths; and establishing the center's college scholarships programs.

She has led a life of quiet dedication to those in need, opening the area's first food bank, now known as the Harry Chapin Food Bank; developing the first Medical Respite Care Center for the homeless; and supervising the fund-raising for the capital campaign that opened the Central Lee County Social Services Campus.
