## 100 Acts of Kindness

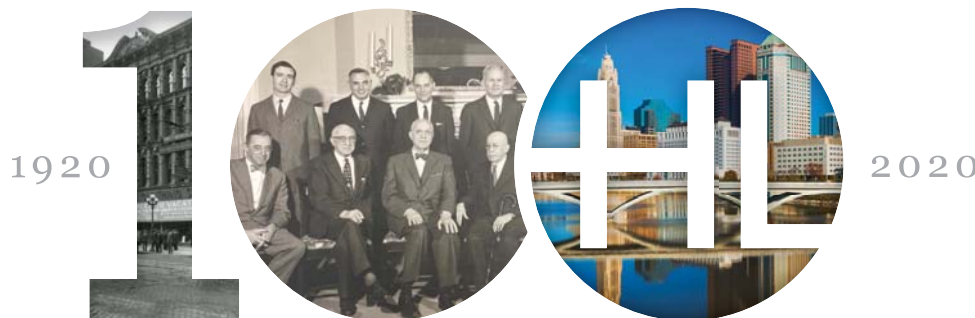
Our attorneys also are invested in the Columbus community, serving on boards and giving back throughout the year. To celebrate our 100th
